The Lead Fire District Board regular meeting was held at 5:30 pm February 22, 2018; in the Lead Fire Hall conference room at 622 Hearst Ave. Suite A, Lead SD.

Present were Board Members; Oz Enderby, President; Tom Baillargeon, Vice President; René Larson, Secretary; Jerry Apa, Treasure; and Kay Rear.

Oz Enderby, President called the meeting to order at 5:30pm.

Minutes: Moved and seconded to approve the January meeting minutes (Apa-Rear). Motion carried. Financial report: Jerry presented the Treasurers report with a balance of \$207,410.22, with \$91,000.35 in Escrow and Deferred Comp \$92,788.90. Moved and seconded to approve the financial report (Larson-Baillargeon). Motion carried. Jerry transferred the \$13000 required to Escrow and moved it to an interest bearing savings account. Two signatures are needed for all checks or moving any funds.

Fire Department bills: The Fire Dept. bills were presented for \$3,669.94. Moved and seconded to approve payment of the Fire Department bills (Baillargeon-Rear). Motion carried.

Fire Department Business: The run report was presented, there were 18 runs. There will be one more hydro test bill coming in. The fire extinguishers and sprinkler system were inspected. There were 7-8 extinguishers that will need to be hydro tested as they are 5 years old. There are 4 people in class in Spearfish and one person working on make-up classes. The Wildland fire class will start following the firefighter class in progress now. The Fire Dept. received a page for a house fire at 312 Sawyer. The Dept members left to respond and Tom left as it was his house involved.
